


# Introduction

The WingMan™ with TriCore® or Torus™ Technology is an interior lighting system that fits in the rear deck area behind the rear seat. The WingMan has room for up to eight TriCore or Torus™ light heads.

## Product Features

TriCore or Torus™ light head options: Red, Blue, Amber, and White-----Flashing

Size: 42.875" long x 2.00" tall x 7.875" deep-----Weight: 7.5 lbs

The use of this or any warning device does not ensure that all drivers can or will observe or react to an emergency warning signal. Never take the right-of-way for granted. It is your responsibility to be sure you can proceed safely before entering an intersection, driving against traffic, responding at a high rate of speed, or walking on or around traffic lanes. The effectiveness of this warning device is highly dependent upon correct mounting and wiring. Read and follow the manufacturer's instructions before installing or using this device. The vehicle operator should insure daily that all features of the device operate correctly. In use, the vehicle operator should insure the projection of the warning signal is not blocked by vehicle components (i.e.: open trunks or compartment doors), people, vehicles, or other obstructions. This equipment is intended for use by authorized personnel only. It is the user's responsibility to understand and obey all laws regarding emergency warning devices. The user should check all applicable city, state and federal laws and regulations. Code 3, Inc., assumes no liability for any loss resulting from the use of this warning device. Proper installation is vital to the performance of this warning device and the safe operation of the emergency vehicle. It is important to recognize that the operator of the emergency vehicle is under psychological and physiological stress caused by the emergency situation. The warning device should be installed in such a manner as to: A) Not reduce the output performance of the system, B) Place the controls within convenient reach of the operator so that he can operate the system without losing eye contact with the roadway. Emergency warning devices often require high electrical voltages and/or currents. Properly protect and use caution around live electrical connections. Grounding or shorting of electrical connections can cause high current arcing, which can cause personal injury and/or severe vehicle damage, including fire. Any electronic device may create or be affected by electromagnetic interference. After installation of any electronic device operate all equipment simultaneously to insure that operation is free of interference. Never power emergency warning equipment from the same circuit or share the same grounding circuit with radio communication equipment. All devices should be mounted in accordance with the manufacturer's instructions and securely fastened to vehicle elements of sufficient strength to withstand the forces applied to the device. Driver and/or passenger air bags (SRS) will affect the way equipment should be mounted. This device should be mounted by permanent installation and within the zones specified by the vehicle manufacturer, if any. Any device mounted in the deployment area of an air bag will damage or reduce the effectiveness of the air bag and may damage or dislodge the device. Installer must be sure that this device, its mounting hardware and electrical supply wiring does not interfere with the air bag or the SRS wiring or sensors. Mounting the unit inside the vehicle by a method other than permanent installation is not recommended as unit may become dislodged during swerving, sudden braking or collision. Failure to follow instructions can result in personal injury. **PROPER INSTALLATION COMBINED WITH OPERATOR TRAINING IN THE PROPER USE OF EMERGENCY WARNING DEVICES IS ESSENTIAL TO INSURE THE SAFETY OF EMERGENCY PERSONNEL AND THE PUBLIC.**



## Unpacking & Pre-installation

Carefully remove the WingMan and place it on a flat surface, taking care not to scratch the lenses or damage the cable coming out of the top. Examine the unit for transit damage, broken lamps, etc. Report any damage to the carrier and keep the shipping carton.

Standard light bars are built to operate on 12 volt D.C. negative ground (earth) vehicles. If you have an electrical system other than 12 volt D.C. negative ground (earth), and have not ordered a specially wired light bar, contact the factory for instructions.

Test the unit before installation. To test, touch the black wire to the ground (earth) and the other wires to +12 volts D.C., in accordance with the instructions attached to the cable (an automotive battery is preferable for this test). A battery charger may be used, but note that some electronic options may not operate normally when powered by a battery charger. If problems occur at this point, contact the factory.

**Note: Before beginning the installation process, be absolutely certain that the Light Bar functions as desired (See page 6 for options)!**

Utilizing non-factory supplied screws and/or mounting brackets and/or the improper number of screws may result in loss of warranty coverage on the equipment.

**Mounting Hardware** - All mounting hardware is packed in a small bag inside the main carton. There are four brackets used to mount the SuperVisor to the vehicle. These are discussed in detail later.

# Installation Instructions

**Step 1** Locate the vehicle's Driver and Passenger outer plastic child restraint brackets in the rear package tray area behind the rear seat and open the hinged bolt covers (see Figures 1 and 2).

**Step 2** Remove the 8mm child restraint mounting bolts with a 1/2" SAE or 13mm metric wrench (see Figure 3). Do not remove the steel spacer and the cardboard washer from the brackets.

**Step 3** Position the WingMan in the rear package tray area (see Figure 4) to determine the desired routing of the cable into the trunk or where ever the final location of the cable is to be. **Note: The best and safest cable routing is to drill a clearance hole for the cable directly through the sheet metal and the interior fabric of the package tray area from inside the trunk of the vehicle directly in line with the cable exit of the WingMan. This keeps the cable out of a passengers reach Note: Move the WingMan out of the way temporarily and make sure any OEM wiring is out of the way so you don't damage the WingMan or the wiring when drilling the cable clearance hole! Route the cable through the hole, pull the slack out of the cable, and reposition the WingMan before going to the next step.**

**Step 4** Push the steel spacer & the cardboard washer down tight against the vehicle's plastic child restraint brackets as shown in Figure 5.

**Step 6** Position the vehicle's plastic child restraint brackets on the supplied WingMan Mounting Brackets as shown in Figure 6. **Note: on the short version of the Caprice WingMan, the mounting brackets are "L" shaped and are driver and passenger side specific as can be seen in the exploded Parts List view on page 7 of this manual. All of the installation steps are the same for both versions.**

**Step 7** Position the WingMan Mounting Brackets with the vehicle's plastic child restraint brackets and thread the vehicle's 8mm child restraint bolt back into the existing hole in the vehicle as shown in Figure 7. Leave the bolts slightly loose at this time.

**Step 8** Thread the supplied 1/4"-20 screws and internal tooth lock washers through the slots in the WingMan Mounting Brackets and into the WingMan's Outer Panel as shown in Figure 8. Thread the screw in until there is very little slack between the WingMan Mounting Brackets and the WingMan Outer Panel but do not tighten the screws at this time.

**Step-9** Center the WingMan in the rear window while pushing it back into position to seal the gasket against the rear window glass. Tighten the vehicle's 8mm child restraint bolt with a 1/2" SAE or 13mm metric wrench as (See Figure 9).

**Step-10** Tighten the 1/4"-20 screws with a phillips screwdriver as shown in Figure 10.

**Step-11** Snap the hinged bolt covers closed on the vehicle's plastic child restraint brackets (See Figure 11).

## Wiring Instructions


It is advisable to leave an extra loop of cable when installing the light bar to allow for future changes or reinstallations. Connect the black lead to a solid frame ground (earth), preferably the (-) or ground (earth) side of the battery, and the power wire to the +12V terminal of the battery. Connect the remaining wires as shown on page 5.




Larger wires and tight connections will provide longer service life for components. For high current wires it is highly recommended that terminal blocks or soldered connections be used with shrink tubing to protect the connections. Do not use insulation displacement connectors (e.g. 3M® Scotchlock type connectors). Route wiring using grommets and sealant when passing through compartment walls. Minimize the number of splices to reduce voltage drop. High ambient temperatures (e.g. under hood) will significantly reduce the current carrying capacity of wires, fuses, and circuit breakers. Use "SXL" type wire in engine compartment. All wiring should conform to the minimum wire size and other recommendations of the manufacturer and be protected from moving parts and hot surfaces. Looms, grommets, cable ties, and similar installation hardware should be used to anchor and protect all wiring. Fuses or circuit breakers should be located as close to the power takeoff points as possible and properly sized to protect the wiring and devices. Particular attention should be paid to the location and method of making electrical connections and splices to protect these points from corrosion and loss of conductivity. Ground terminations should only be made to substantial chassis components, preferably directly to the vehicle battery. The user should install a fuse sized to approximately 125% of the maximum Amp capacity in the supply line to protect against short circuits. For example, a 30 Amp fuse should carry a maximum of 24 Amps. **DO NOT USE 1/4" DIAMETER GLASS FUSES AS THEY ARE NOT SUITABLE FOR CONTINUOUS DUTY IN SIZES ABOVE 15 AMPS.** Circuit breakers are very sensitive to high temperatures and will "false trip" when mounted in hot environments or operated close to their capacity.

FUSE WITH CUSTOMER SUPPLIED 10 AMP FUSE




# Wiring Diagram - WITH ARROWSTIK®



# 6 HEAD ARROWSTIK® W (2) OUTER LIGHT HDS FLASHING ALTERNATELY

The WingMan™ can be configured as a 6 or 8 head ArrowStik. To change the WingMan from an 8 head ArrowStik to a 6 Light Head configuration with the (2) Outboard Light Heads flashing alternately, remove the mounting screws that attach the WingMan's Cover to the Outer Panel to gain access to the printed circuit board inside (see the exploded view on page 7). Move the Shunt Option Jumper (JP1) on the printed circuit board to the "OPTION JP1" position as shown below. When configured for a 6 head operation the (2) Outboard Light Heads will alternate during any ArrowStik mode. Carefully replace the WingMan's Cover over the Outer Panel and replace the Cover Mounting Screws.

**Note:** Be extremely careful to replace the wiring such that you don't pinch a wire when you replace the WingMan's Cover. Test the unit to be sure that it works properly.



## Flash Pattern Changes

**WARNING!**



This Product contains high intensity TriCore® or Torus devices. To prevent eye damage, DO NOT stare into light beam at close range.

### TriCore® or Torus™ Light Head Flash Pattern

To change the flash patterns of the TriCore® or Torus™ Light Heads for either Standard or ArrowStik® patterns, activate the Light Bar in Level 1 or any ArrowStik mode and then momentarily touch the Green (Pattern Select) wire to +power. Repeating this procedure allows the operator to cycle through the numerous flash patterns offered until the desired pattern is achieved. Repeat for all modes as needed.

**Note:** Each ArrowStik mode must be set individually.

To reset the flash patterns to the factory default, activate the Light Bar in Level 1 or any ArrowStik mode and then hold the Green (Pattern Select) wire to +power for approximately 4 seconds.

- Note:**
- 1-Resetting the Standard patterns will reset only the Level 1 flash patterns
  - 2-Resetting the ArrowStik patterns in any ArrowStik mode will reset all ArrowStik flash patterns.



# WARRANTY

This product with TriCore® or Torus™ Technology was tested and found to be operational at the time of manufacture. Provided this product is installed and operated in accordance with the manufacturer's recommendations, Code 3®, Inc. warrants all parts and components (with the exception of all incandescent and halogen bulbs) of the product to be free of defects in material and workmanship for a period of one (1) year and TriCore or Torus™ light heads for a period of five (5) years from the date of purchase. This Warranty excludes normal wear & tear. Units demonstrated to be defective within the warranty period will be repaired or replaced at the factory service center at no cost. Code 3, Inc. will return the repaired product with transportation cost prepaid. Code 3, Inc. assumes no liability for expenses incurred in the packaging, handling, and shipping of the product to the Factory Technical Service Department for repair. For in-warranty product return authorization, questions regarding product warranty coverage or questions regarding out-of-warranty repair quotes, contact the Factory Technical Service Department.
