

# **CODE 3®** Installation and Operation Instructions **CW2310 & CW2311 LED WORKLAMPS**

Code 3's CW2310 and CW2311 LED Worklamps feature nine 10-watt LEDs that produce an extremely high-intensity beam as well as an aluminum heatsink housing, heavy-duty stainless steel mounting bracket and tough polycarbonate lens to withstand the most demanding applications. These highly durable worklamps are designed to perform in the harshest of work environments and offer all the benefits of LED technology including the brightest white light output, a long, maintenance-free service life and extremely low current consumption.

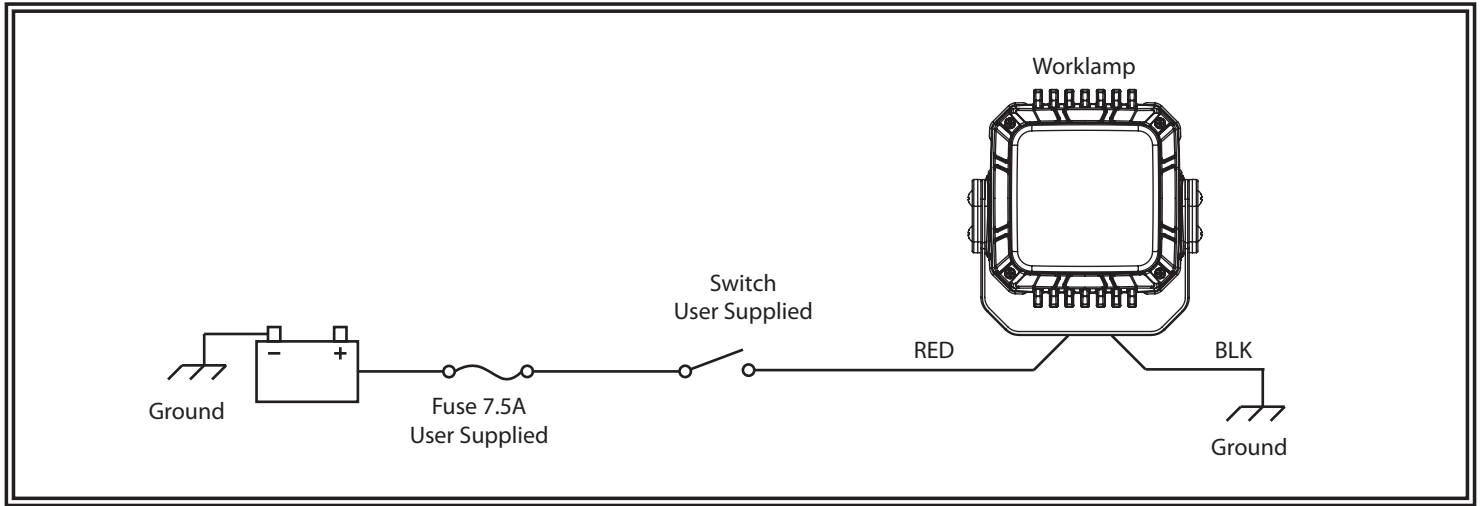
## **Installation:**

1. Select a mounting location for the unit on a flat surface. Place the unit bracket, flat side down, on the surface.
2. Use the two circular slots in the bracket to mark the drill locations for mounting. Drill two 0.397 diameter through holes (X drill bit) through the mounting surface. Align the base with the mounting holes, and use 3/8"-16 hardware (include bolts, flat washers, lock washers, and nuts) to mount the bracket to the surface. Position the unit in the horizontal direction, and tighten both nuts.
3. To position the unit vertically, use a 5/32" hex L-key to loosen the two screws on each side of the bracket. Tighten the screws when pivoted properly.

## Wiring Instructions:

Black Wire: Ground  
Red Wire: Connect to fused power
