



# CW2461 LED Magnet Mount Worklamp

Featuring a high intensity flood beam and three operating modes (100% intensity, 30% intensity & SOS flashing) this heavy duty battery powered worklamp combines mobility with high performance and a compact design. The long-life, lithium rechargeable battery allows the worklamp to be operated for 3-4 hours before recharging is required. Dual color CWR model features five operating modes (100% intensity white, 30% intensity white, 100% intensity red, double flash red and quad flash red). A cigarette socket charging lead and AC adapter are supplied with all models.

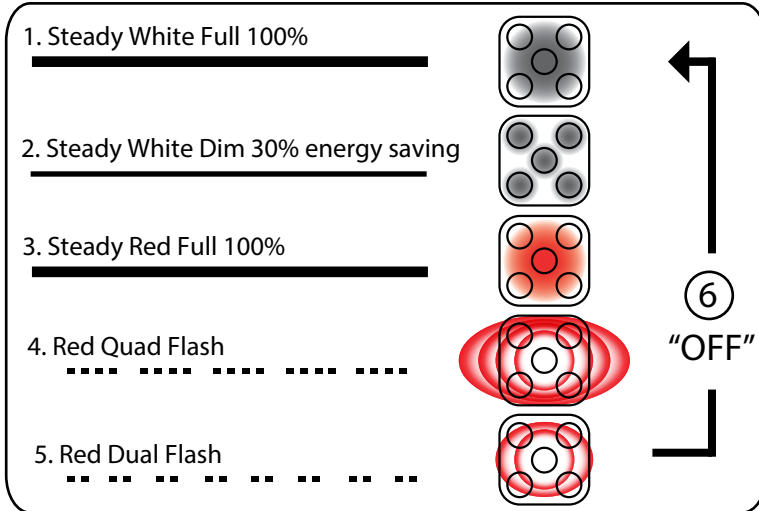
1. Mount the unit on a flat, clean, dry surface.
