# OSCILASER RETROFIT KIT

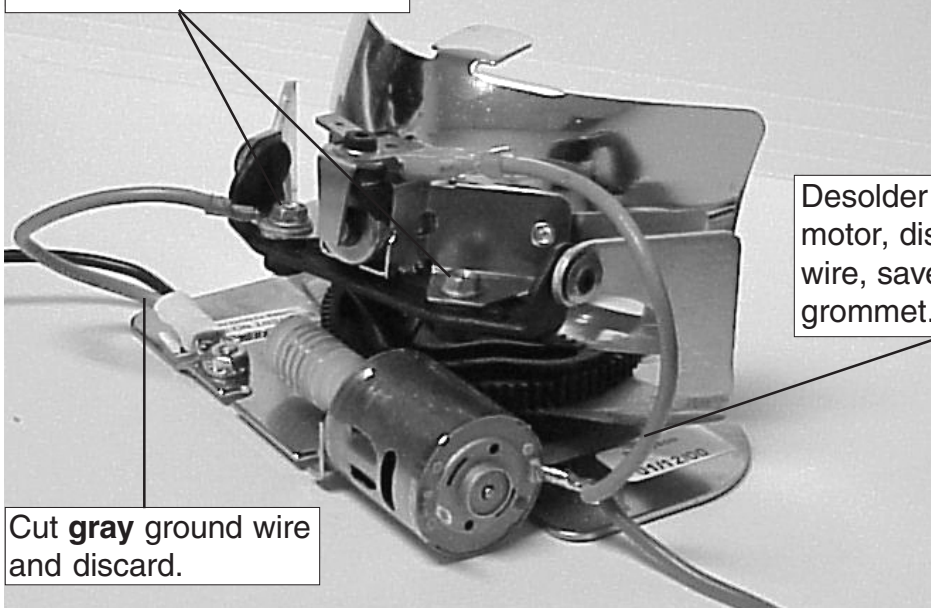

**IMPORTANT:**

*Read all instructions and warnings before installing and using.*

**INSTALLER:** *This manual must be delivered to the end user of this equipment.*

Remove the reflector from carriage (save the 2 1/4 inch hex screws) and discard.



Desolder both wires at motor, discard gray flex wire, save red wire with grommet.

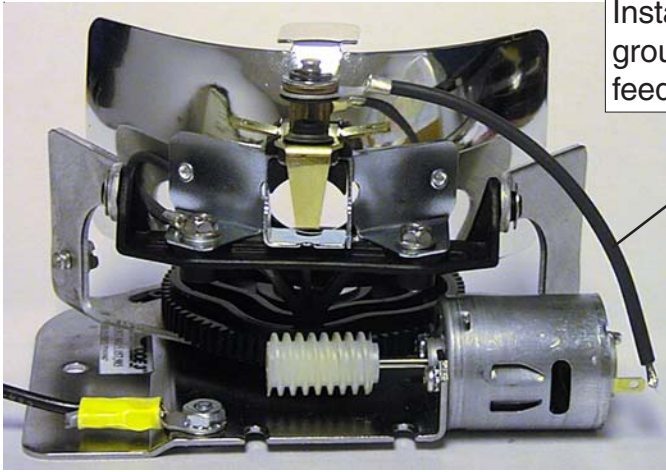
Cut **gray** ground wire and discard.

Drill one 9/64 hole in bracket as shown. Measure down 1 inch from edge and center in the bracket.



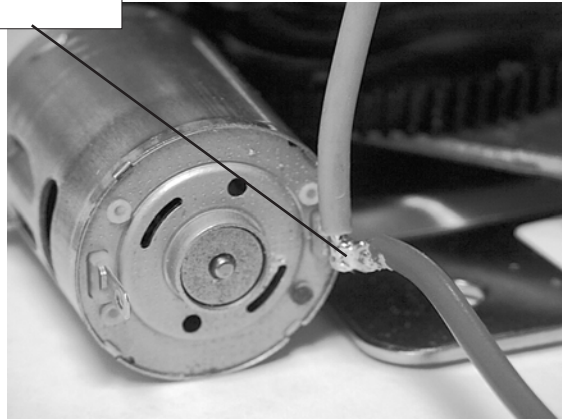
Install new ground jumper as shown.



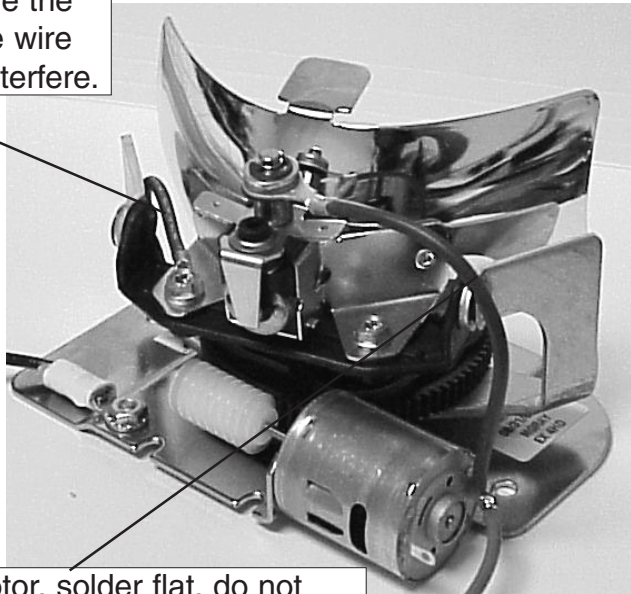


Install new reflector. Attach ground jumper and positive feed wire.

Detail of solder joint showing direction of wires.



Note gap between ground wire and plastic carriage. Angle the ring terminal such that the wire and the carriage do not interfere.



Solder positive wires to motor, solder flat, do not twist the wires together. Install in housing, connect power and ground wire.
